Legacy Heritage of Woman's Wednesday Club

Typically, pioneer women carried the refinement, moral character and spiritual force into the West. They bore the burdens of daily toil and rearing of families. They were intent that children should have opportunities; thus, the beginnings of schools, churches and eventually social and educational gatherings emerged in the frontier. A pinnacle in pioneering history was reached when women were honored with the pre-eminent part they played in shaping the destinies of Texas.

Woman's Wednesday Club of Granbury, organized in 1897, brought women together to hear programs on current events, patriotism, culture, literature, the arts and home and family life. Club projects included improvement in the community by landscaping of school grounds and the court-house lawn, a "Don't Spit on the Sidewalk" campaign, participating in the town's centennial celebration, cemetery care, sponsoring a girl to Girl's State, gifts to patients in local and state hospitals and supporting the library and senior citizen center.



What do we know about these women and their families? They include the daughter of the founder of the First National Bank in Granbury, wives of merchants, contractors, a cotton gin operator, superintendent of Granbury School District, a doctor and a member of the Texas Legislature. One was the wife of A. W. Crockett, grandson of David Crockett, editor of Granbury Graphic and Granbury Tablet. Other notables include the first female county attorney in Texas and the first female district clerk, as well as wives of immigrants and Civil War veterans. Streets were named after them such as: Boswell, Crockett, Hannaford, Morgan, Pate and Thrash. Historical houses and buildings are also named for their families: Cooper, Dabney, Doyle, Gordon and Shanley.

Woman's Wednesday Club's original concerns for the spirited pioneer woman included a better way of life and the influence that all women have on local, state, national and international movements. To this end, our goal is to make our members a more integral part of the community by expanding our services, involvement and contributions to various community agencies and projects through monthly programs.



"Would you like some coffee? I like mine black—Folgers medium dark roast. It's not sold everywhere. I don't like it when I'm in a part of the country that doesn't sell Folgers," laughs Dora, standing in her clean white kitchen. A thicket of pecan trees spreads down a slope to the Brazos River outside the sunny windows of her Pecan Plantation house.

She was born in Del Rio but moved to the family ranch, the Calhoun Ranch, and graduated from Granbury High School in 1946 and TCU in 1950. Following marriage, she and Louis operated an accounting firm in Amarillo where she gained skills as a CPA. After retirement, she and Louis returned to the Calhoun Ranch but the bad roads dictated a move to Pecan. "Motherhood," she said, "came late in life and so grandmotherhood came late, too."

When Dora joined WWC in 1984, the club had its meetings on the first and third Wednesday of each month at 2:00 o'clock, September through May. Since some members had to leave early to collect their children, the meeting time was changed to noon and became a luncheon meeting. "Light refreshments were served at the meetings with little sandwiches and a lot of treats but that evolved into a full meal. So, it wasn't much different to serve lunch," Dora remembers.

Several benchmark accomplishments of the Woman's Wednesday Club stand out in Dora's mind. First, when Sally Cleveland was club president in 1984, they met in the hall of the Good Shepherd Episcopal Church in Acton. WWC set a goal to have their own clubhouse and many fundraisers ensued to finance this dream. During the presidency of Minnie Mae Hall, the cornerstone for the clubhouse was laid in 1987. Many members contributed to the building fund and Dora recalls that First National Bank was very helpful. "It didn't hurt that the banker's wife was a member." The clubhouse was paid for in a very short time after a flurry of activity to decorate and furnish it.

Dora was central to a second important club event when she employed her CPA background to promote more professional financial record keeping. "The treasurers before used a very casual list of incomes and expenses on a tablet. I usually served two bienniums as treasurer, then two bienniums as chairman of the audit committee, as the bylaws allow," Dora said. She was club president in 2000-2002.

Gaining our club 501(c)(3) tax exempt status in 1987 under the umbrella of GFWC is a third achievement that members of our club benefit from today as not every club is designated a charitable organization. "Yes, 1987 was a busy year," Dora remembers.

In the late 1980's, church clothes were appropriate club meeting attire and some members wore hats. In 1998 when Louise Taylor was president, WWC began to meet only on the first Wednesday at 1:00 p.m. with dessert. "Everyone was happy about that!"

Dora has fond memories of tours or field trips to other clubs or to venues in Dallas or Fort Worth, of fundraisers when Janeen's clothing store (a Granbury landmark, now closed) supplied all the fashions for the style show, of Game Day selling \$5 tickets to the community to participate in games and food and cookbook sales and bake sales. With humility, she shared her activities in WWC that have changed the club for the better, all done with the spirit of willingness and cooperation that is the hallmark of the Woman's Wednesday Club of Granbury.
