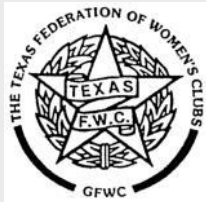

Meeting - 1:00 p.m.

President Cheryl Troxel called the meeting to order, and in the absence of Pat Harpster, delivered the invocation.

President Troxel thanked the hostesses: Chair Peg Harding, Cheryl Patterson, Carolyn Riley, Sally Timmons and Robin Echols.

Francine Raper led the pledges of allegiance to the flags of the United States and Texas.

Jackie Gilbert introduced member JJ Mainord who presented the International Outreach program on UMCOR and her participation in the United Methodist Committee on Relief international emergency relief mission based in Baldwin, LA.

Treasurer Melinda Charbonnet presented the balance sheet and profit and loss statements (attached) and noted that the club has over \$9,000 more than a year ago even after distributing the scholarship monies. She also noted that the most recent utility bill had been unusually high.

WWC chair and GFWC Texas 2nd Vice President Carolyn McLeod distributed the official state annual reporting forms for volunteer hours (attached) and advised that the volunteer hours that members submit must be associated with organizations that our club supports or with whom we partner.

Membership chair Pat Flatt announced the resignation of Marilyn Klein and Laurie Viselli. Nita Richardson requested to move to Honorary Life Membership. After determining that a quorum was present, Nita Richardson's change of status was unanimously granted by a voice vote. [President Cheryl Troxel noted that with the votes obtained from two absent executive committee members at

the board meeting that a quorum was present and conducted the vote.] Members were encouraged to nominate new members to fill these openings.

Clubhouse chair Linda Somervill reported that two lighted exit signs were installed above the exit doors to comply with insurance.

Marian Winslow distributed information about the GFWC Conservation field trip to the Dallas Arboretum on March 13. The cost of \$20 includes both a tour and lunch and is payable on or before Feb. 6, 2019. Members should also turn in their lunch selection at that time.

In the absence of Community chair Mary Moore President Troxel requested a volunteer to chair the Jan. 14-18 food activities planned for the CPS workers.

In the absence of Corresponding Secretary Bobbie Fallin members suggested that get well cards be sent to Shirley Capps, Bobbie Brownlee, Mary Moore and Pat Harpster.

Federation Counselor Ernestine Shugart encouraged members to enter poetry, short story or photography contests at the upcoming district meeting March 23 in Comanche.

Other important dates are GFWC Texas Spring Convention, April 24-27 in Austin, and the GFWC Annual Convention, June 29-July 1 also in Austin. Carolyn McLeod urged members to attend and host at the opening night pre-event on June 28, as she is responsible for the event. Ernestine Shugart displayed the

December 2018 issue of The Texas Clubwoman with photos of some of our members and featured an article on membership written by 2nd Vice President of GFWC Texas Carolyn McLeod.

President Cheryl Troxel reported that the executive committee had voted to donate \$25 to the Silsbee club in memory of their recently deceased club president Kathy McBride. The president announced that the champagne on the table centerpieces were door prizes.

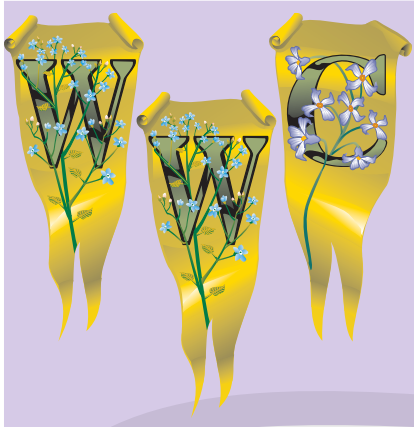

serving as a force for global good, as it has done since its formation 128 years ago.

With over 80,000 members in affiliated clubs in every state, the District of Columbia, and more than a dozen countries, GFWC members work in their own communities to support the arts, preserve natural resources, advance education, promote healthy lifestyles, encourage civic involvement, and work toward world peace and understanding.

Founded in 1890, GFWC's roots can be traced back to 1868 when Jane Cunningham Croly, a professional journalist, attempted to attend a dinner at an all-male press club honoring British novelist Charles Dickens. Croly was denied admittance based upon her gender, and in response, formed a woman's club—Sorosis.

In celebration of Sorosis' 21st anniversary in 1889, Jane Croly invited women's clubs throughout the United States to pursue the cause of federation by attending a convention in New York City. On April 24, 1890, 63 clubs officially formed the General Federation of Women's Clubs by ratifying the GFWC constitution.

Since 1890, GFWC's impact has been

felt throughout communities across the United States and the globe.
